## PURPOSE OF THE PROCESSING

The personal data referring directly to the Customer or, for essentially identifying data, those referring to other data parties (such as collaborators, employees, contacts, etc.) collected by Ciambella Legnami S.r.l will be used to guarantee the services offered by the Data Controller and for the performance of the precontractual relationship (sending commercial or preventive information, management of commercial negotiations, etc.) and contractual information (contract execution, order acquisition, transport documents, invoices, accounting, etc.).

#### **OBLIGATION TO PROVIDE DATA**

The provision of data is mandatory for everything regarding the execution of contractual, administrative, and legal obligations regarding the supply relationship. Any refusal to provide the data, or revocation of consent, makes it impossible for the company to execute the contract and perform all the necessary requirements.

### PROCESSING METHODS

Processing is carried out in compliance and with respect to the provisions on the processing and protection of personal data both on paper and with the aid of management software and electronic tools for storing, managing and transmitting the data.

#### STORAGE PERIOD

The data will be kept for the execution of the contractual relationship, beyond which the data will be kept for the time needed to complete administrative, accounting and fiscal purposes related to the relationship established, and also arising from the obligations provided by law, however within the prescribed time limits set for the rights and obligations subject to the processing. The contractual data provided by the customer will be stored to allow the Ciambella Legnami S.r.I to propose also further products similar to those already supplied.
